Getting an ID

Colorado Road and Community Safety Act (CO-RCSA) provides temporary and undocumented Colorado residents a way to get a state ID. These credentials are not a REAL ID compliant driver license. These identification CAN NOT be used for federal purposes, voting or public benefits. CO-RCSA IDs are a valid Colorado identification.

What you need to get an ID

To prove your residency, you need to provide two of the following that include your name, address, and are dated within the last year:

- Utility bill or phone bill
- Lease agreement, mortgage statement, or rental receipt in your name (receipt cannot be handwritten)
- First class mail dated with postmark
- Note: Mail addressed with a label or not postmarked first class mail by USPS will not be accepted.
- Credit card or bank statement
- Insurance policy
- Pay stub
- Vehicle registration or title
- Colorado ID/license with current address

Costs of Getting an ID

If you need help covering the cost of your identification, there are a few locations throughout Denver metro where you can pick up a voucher. Vouchers are redeemable at Denver Vital Records, Colorado Department of Public Health & Environment and participating DMV locations.

Vouchers are given out daily at many locations between 8:30 a.m. and 4:30 p.m. though days and times may vary. Please confirm with the specific location prior to your visit. Funds are limited so if you do not get a voucher, try back.

Individuals in need of Identification assistance (birth certificate, Colorado driver's license, SSN), can start by following these steps:

- Reinstating and identification document
 - Colorado Department of Motor Vehicles
 - Application for Reinstatement (Form #DR 2870): <https://dmv.colorado.gov/sites/dmv/files/DR2870.pdf>
 - Frequently asked questions <https://dmv.colorado.gov/reinstatement-frequently-asked-questions>
 - Example fees: \$95.00 reinstatement fee + \$25.00 DUI restoration fee
- **What is an SR-22 and how do I know if I need one?**
 - You may be required to file an SR-22 when you reinstate from specific suspensions and/or revocations.
 - In Colorado, you may be required to have SR22 insurance in one of two cases; if you've been in an accident and must fulfill a Financial Responsibility requirement or if your license has been suspended/revoked.
 - The SR-22 requires the insurance company to notify the DMV of any policy cancellation. The SR-22 form is not an insurance policy.
 - If you don't keep the SR-22 current, the insurance company will notify the Motor Vehicle Division that the SR-22 is no longer in effect, but is still required. Your driver license will be suspended for that reason alone.
 - If you decide to change insurance companies, you must get a new SR-22 filed before the old one expires.
 - When you purchase liability insurance, the insurance agent can provide the SR-22 form. When the liability insurance with the SR-22 rider is purchased, the form must be filed with the Colorado Division of Motor Vehicles.
 - You may upload the SR-22 form at MyDMV.Colorado.gov. Find the View/upload reinstatement documents link near the bottom of the Driver/ID Services website tab, or you may mail it in with the Application for Reinstatement (Form DR 2870) and any other requirements necessary for reinstatement.
